

UCG Match Support Task Force Terms and Conditions

1. Purpose

These Terms and Conditions establish the certification, activity requirements, and benefits applicable to individuals who satisfy the standards prescribed by Tsuburaya Fields Entertainment International Pte. Ltd. (hereinafter referred to as the “**Company**”) and are certified as **UCG Match Support Task Force Members** (hereinafter referred to as “**UCG MST Members**”) in connection with the trading card game “**Ultraman Card Game**” (hereinafter referred to as the “**Product**”) released by the Company, with the objective of promoting the healthy development of the Ultra League community.

UCG MST Members may be granted eligibility to organize authorised tournaments and receive other benefits subject to the conditions separately determined by the Company.

2. Certification Requirements

The Company may certify an individual as a UCG MST Member if the individual satisfies all of the following requirements and is otherwise deemed qualified by the Company:

1. Has no material history of violations of the Ultra League Charter or any other rules established by the Company.
2. Holds a Company-certified Judge qualification at the Advanced level or higher.
3. Is otherwise deemed suitable by the Company to serve as a UCG MST Member.

The following may be considered an additional qualification:

- Has demonstrated meaningful contributions to the community during the preceding one-year period in accordance with certification criteria established separately by the Company.

3. Benefits

1. During the certification period, the Company may provide UCG MST Members with the following benefits:

(1) Eligibility to Organize Authorised Tournaments

- UCG MST Members may use the “ULTRA LEAGUE for Organize App” to organize and operate authorised events.
- However, UCG MST Members may not organize event series that have been specifically designated by the Company.

(2) License to Use Digital Assets

- The Company grants a non-exclusive, revocable and non-transferable license to use designated digital assets solely for the purpose of promoting the authorised event organized by the respective MST member.
- Such use must comply with the asset usage rules

separately established by the Company. Modification, redistribution, sublicensing, or any other use not expressly authorised by the Company is prohibited.

2. The Company reserves the right to suspend, modify, or discontinue any benefits described above if it reasonably determines that such action is necessary.

4. Compliance Obligations

UCG MST Members shall comply with the following obligations:

1. Comply with these Terms and Conditions, the Ultra League Charter, and all other rules established by the Company.
2. Conduct tournaments fairly, responsibly, and refrain from any conduct that may harm the healthy development of the community.
3. Properly manage and use any benefits, promotional materials, digital assets, or other resources provided by the Company in accordance with applicable requirements.
4. Cooperate with reasonable requests from the Company relating to reports, audits, confirmations, or other matters necessary to maintain certification.
5. If there are any changes to the information submitted at the time of certification application, the applicant must notify the Company in advance and obtain the Company's approval.
6. Refrain from any conduct that may damage the credibility, reputation, goodwill or brand value of the Company or the Product.

5. Prohibited Conduct

UCG MST Members shall not engage in any of the following activities:

1. Reselling, or engaging in similar activities involving items or promotional materials intended for Authorised Stores, including PR cards.
2. Neglecting UCG MST Member responsibilities or activities to a significant degree without legitimate reason.
3. Engaging in conduct that violates the Ultra League Charter, including but not limited to facilitating cheating or discriminatory behaviour.
4. Providing false, misleading, or incomplete information in connection with a certification application or certification-related process.
5. Changing any information submitted as part of the certification application without the Company's prior approval.
6. Engaging in any other conduct that may damage the image, reputation, or brand value of the Company, the Product, or the Ultra League community.

6. Certification Procedures

Application procedures, evaluations, and all other matters related to certification shall be determined separately by the Company. If there are any changes in the information provided in the application, the applicant must promptly notify the Company. The applicant must not make any such changes without first obtaining the Company's prior

approval. If the applicant violates this provision, the Company may suspend the review process or reject the application for certification.

7. Revocation of Certification

The Company may revoke certification and suspend or terminate any associated benefits without prior notice if it reasonably determines that a UCG MST Member falls under any of the following circumstances:

- (1) Has violated these Terms and Conditions.
- (2) No longer satisfies the certification requirements set forth in Article 2.
- (3) Submitted false, misleading, or incomplete information during the application process or in related materials.
- (4) Is otherwise reasonably deemed unsuitable to continue serving as a UCG MST Member.

8. Amendment of Terms

The Company may amend these Terms and Conditions at any time as necessary. In the event of any amendment, the Company shall notify UCG MST Members through its website or by any other method deemed appropriate by the Company.

9. Term of Certification

The certification period for UCG MST Members shall be one (1) year from the date of certification. Upon expiration, certification may be renewed in accordance with procedures established by the Company. However, any renewal shall be subject to the Company's review and approval and shall be granted solely at the Company's discretion.

10. Prohibition on Assignment of Rights

UCG MST Members may not assign, transfer, sublicense, lend, or pledge as collateral any benefits provided under Article 3 to any third party.

11. Exclusion of Anti-Social Forces

UCG MST Members represent and warrant that neither they nor their related parties are members of, affiliated with, or acting on behalf of any anti-social force or criminal organization.

If the Company discovers that such affiliation exists, the Company may immediately revoke certification and terminate any associated benefits.

12. Governing Law and Jurisdiction

These Terms and Conditions shall be governed by and construed in accordance with the laws of Singapore. Any disputes arising out of or relating to these Terms and Conditions shall be subject to the exclusive jurisdiction of the courts of Singapore as the court of first instance.
