ULTRA LEAGUE WORLD CHAMPIONSHIP 2026 QUALIFIERS Terms and Conditions

These Rules and Regulations apply to all participants in the "ULTRA LEAGUE WORLD CHAMPIONSHIP 2026 QUALIFIERS" (hereinafter referred to as "this Tournament") for the right to compete in the "ULTRA LEAGUE WORLD CHAMPIONSHIP 2026" (hereinafter referred to as "the World Championship") organized by Tsuburaya Productions Co., Ltd. (hereinafter referred to as "the Company"). By applying to participate in this Tournament, you are deemed to have agreed to all the contents of these Terms and Conditions.

Chapter 1: General Provisions

Article 1 (Purpose)

This Tournament is held for the purpose of promoting the Ultra League, fostering interaction among players, and improving the level of competition. Top-performing participants in this Tournament will be granted the right to participate in the World Championship.

Article 2 (Application of these Terms and Conditions)

- 1. These Terms and Conditions apply to all Qualifiers held in Japan and in countries around the world. Detailed operational methods for each Qualifier will be announced separately on the tournament overview page, etc., as determined by the Company.
- 2. Unless otherwise specified in these Terms and Conditions, terminology used herein shall have the same meaning as defined in the Ultraman Card Game Comprehensive Rules (https://ultraman-cardgame.com/lp/rule/UCG_Comprehensive_rule_ENG.pdf) and the Ultraman Card Game Floor Rules (https://ultraman-cardgame.com/lp/rule/UCG floor rule ENG.pdf).

Chapter 2: Eligibility

Article 3 (Eligibility)

- 1. Only individuals who have agreed to these Terms and Conditions and the Company's Privacy Policy, and who have completed the participation application process, may participate in this Tournament.
- 2. A TCG ID issued by the Company is required for the participation application process. Individuals who do not possess a TCG ID cannot apply.
- 3. Only individuals residing in the country or region where an Regional Qualifier is held may participate in that Regional Qualifier.
 - a) "Residency" refers to the state in which a participant is legally permitted to reside in

that country or region and has their permanent and principal home there at the time of this Tournament. In Japan, this will be determined by the address on the certificate of residence. Outside of Japan, this will be determined by equivalent official registration information or a long-term stay visa, along with objective evidence demonstrating long-term residency in that country/region (e.g., passport, lease agreement, utility bills, etc.).

- b) If any false declaration is discovered, measures such as revocation of eligibility, nullification of results, and a ban from future events organized by the Company may be taken.
- 4. The Company may, at any time, require participants to present official government-issued identification (passport, driver's license, or other documents approved by the Company) as proof of residence.
- 5. The following individuals are not eligible to participate in this Tournament:
 - a) Employees of the Company and parties related to this Tournament.
 - b) Players who are currently under a suspension penalty.
 - c) Individuals whom the Company determines to belong to or be associated with antisocial forces.

Chapter 3: Tournament Operation

Article 4 (Tournament Format and Rules)

- 1. Detailed rules such as the regulations, match format, time limits, and usable cards for this Tournament shall be in accordance with the separately established "Floor Rules" and announcements on the official website.
- 2. Participants must follow the instructions of judges and event staff. Failure to do so may result in penalties.

Article 5 (Prohibited Acts)

Participants shall not engage in the following acts:

- a) Fraudulent acts (cheating, collusion with opponents, etc.).
- b) Unsporting conduct (abusive language, intimidation, harassment, etc., towards opponents, staff, or other participants).
- c) Intentional delays that hinder the progress of the tournament.
- d) Gambling related to this Tournament, unauthorized sale of goods, and solicitation.
- e) Any other acts that violate the Floor Rules established by the Company or that the Company deems inappropriate.

Article 6 (Penalties)

If a judge or event staff determines that a participant has violated, or is at risk of violating, the prohibited acts in the preceding article, penalties may be imposed according to the severity of the violation, including but not limited to a caution, a warning, a game loss, disqualification, revocation of the right to participate in the World Championship, and suspension from future events organized by the Company.

Chapter 4: Rights and Responsibilities

Article 7 (Right to Participate in the World Championship)

- 1. Top-performing participants in this Tournament will be granted the right to participate in the World Championship (hereinafter referred to as "this Right"). There are two types of this Right: "Sponsored Participation Right," for which the Company will provide the participant a round-trip flight from the country or region of this Tournament and accommodation for participation in the World Championship (limited to the scope designated by the Company), and "General Participation Right," for which the Company will not provide such support.
- 2. This Right belongs exclusively to the individual who earned it and cannot be transferred, sold, or loaned to any third party.
- 3. If a recipient of this Right declines or is unable to participate, is not eligible to receive this Right, or loses their eligibility, the Company may, at its discretion, pass down this Right to the next-ranked player. This pass-down process will continue sequentially until an eligible player accepts this Right.

Article 8 (Special Provisions for Minors and/or Participants in Regions with Legal Restrictions on Personal Information Acquisition)

1. If a minor or a person subject to legal restrictions on the acquisition of personal information (hereinafter referred to as "Minors, etc.") wishes to participate in this Tournament, the consent of a parent or legal guardian (hereinafter referred to as "Guardian, etc.") is mandatory for application. The Company will require the submission of a consent form in a designated format.

If a participant who is under 18 years of age as of 1st January 2026 is granted "Sponsored Participation Right", the following additional conditions will apply:

- a) Accompaniment by a Guardian, etc.:
 One Guardian, etc., must accompany the participant for participation and travel to the World Championship.
- Sponsored Participation Coverage:
 The Company will provide the participant and one accompanying Guardian, etc. each
 a round-trip flight from the country or region of this Tournament and accommodation

- for participation in the World Championship (limited to the scope designated by the Company).
- 2. In the U.S. Regional Qualifiers, players under the age of 13 as of 1st January of the year of this Tournament cannot acquire this Right.

Chapter 5: Miscellaneous

Article 9 (Handling of Personal Information)

- 1. The Company will use personal information obtained upon application for participation within the scope of the purposes for use defined in the TSUBURAYA Account Privacy Policy (https://account.ultraman-cardgame.com/sg/privacypolicy).
- 2. In addition to the preceding paragraph, the Company will use the personal information obtained thereby for the following purposes:
 - a) To confirm eligibility for, process registration for, and communicate with participants of this Tournament and the World Championship.
 - b) For the smooth operation, management, and announcement of results for this Tournament and the World Championship.
 - c) To grant the right to participate in the World Championship to the qualifiers and for related procedures.
 - d) For promotional activities related to this Tournament and the World Championship (including the use of likeness, name, participant name, interviews, match videos, etc.) on websites, social media, video streams, and in information provided to the press.
 - e) To prevent and investigate fraudulent activities and to apply penalties to violators.
 - f) To create and analyze statistical data regarding tournament operations.
 - g) To improve, develop, and plan this Tournament and related events.
 - h) For tasks incidental to each of the above purposes.
- 3. The participant shall agree to the Company's handling of customer information in accordance with the said Privacy Policy.

Article 10 (Image Rights and Publicity Rights)

- 1. The Company and third parties authorized by the Company may record the events of this Tournament in photographs and video.
- 2. Participants agree that their likeness, name, participant name, interviews, and match videos may be published and used free of charge, without restriction as to region or duration, on the Company's websites, social media, promotional materials, related products, video streaming sites, and the like.

Article 11 (Disclaimer)

- 1. In the event that holding this Tournament becomes difficult due to natural disasters, war, terrorism, the spread of infectious diseases, or other reasons not attributable to the Company, the Company may cancel, postpone, or change the content of the tournament without prior notice. The Company shall not be liable for any damages incurred by participants as a result of such changes.
- 2. The Company shall not be liable for any loss or theft of personal belongings or for any trouble between participants in concern to this Tournament .

Article 12 (Changes to the Terms and Conditions)

The Company may change the contents of these Terms and Conditions as necessary. The revised Terms and Conditions shall become effective upon being posted on the official website, and the revised terms shall apply to all subsequent participants.

Article 13 (Governing Law and Jurisdiction)

These Terms and Conditions shall be governed by the laws of Japan. The Tokyo District Court shall be the exclusive court of first instance for any and all disputes arising out of or in connection with these Terms and Conditions or this Tournament.
